ENFORCEMENT AND PENALTIES: Any and all Board Members and/or Lake Buckhorn employees shall be authorized to report violators to the Board for imposition of fine.

#### FINES AS ADOPTED AT THE 2003 ANNUAL MEETING

1<sup>st</sup> Violation – Written Warning 2<sup>nd</sup> Violation - \$50.00 Fine

3<sup>rd</sup> Violation - Vehicle is barred from Association property and road ways

- > It is understood that it is a privilege and not a right to operate such vehicles within Lake Buckhorn Subdivision.
- If it is determined that the operation of these type vehicles constitutes a hazard to the safety and well-being of the entire community, the LBPOA Board of Trustees may at any time stop the operation of any and/or all of these vehicles.
- ➤ NO GUEST AND/OR VISITOR is never permitted to bring any such vehicle into Lake

  Buckhorn Subdivision. Furthermore, the LBPOA accepts absolutely no responsibility or liability

  for the safety and/or wellbeing of any individual(s) riding any such vehicle.
- ➤ The vehicle <u>must be</u> operated according to the road and traffic conditions. All vehicles must operate within the speed limits as posted within the Lake Buckhorn Subdivision.
- > OPERATING TIME FOR RECREATIONAL USE of any of the above-mentioned vehicles will be 8:00 a.m. until ½ hour after sunset unless properly equipped with lights (e.g., headlights, taillights, brake lights, etc.). Because these types of vehicles are not normally equipped with turn signals, all

drivers must be prepared to use the recognized hand signals used to indicate a left turn, right turn, or slowing down of the vehicle.

> These vehicles may not be used upon any of the recreational areas of Lake Buckhorn Subdivision or nay LBOPA-owned lots without the express consent of the LBPOA Board of Trustees.
