Our for forecast revenue for last year was \$660,000 we took in \$703,000 a \$42,000 surplus we spent \$33,000 less than forecast on general administration, we spent \$20,000 less on maintenance expense and we spent \$24,000 less on payroll, however we spent \$100,000 on the roads which gives us a net gain

of \$32,005 for the year. Dan questioned what was the reason for the revenue increase their was almost \$60,000 in new memberships fee's.

#### **Open Session:**

**Bob Lessing:** Have the 2018 Annual and Special Meetings of Members Minutes been drafted yet? If so, how may I obtain copies before the 2020 Annual Meeting? If not, I renew my willingness to assist in preparing the 2018 Minutes. What is the status of looking into the use of a hearing aid "loop" in the Hall? Alternatively, have you looked into the feasibility of sound-proofing the Hall? Rosemarie will put the minutes on an external drive for you to pick up. As for the loop it is over \$8,000 for the installation of the loop, and that anyone who would use it would have to download or pay for an app, what we are looking into is upgrading the sound system, so that we don't get the feedback that more people will benefit from it

**Beverly Wilkinson's:** Why is there no basketball backboard and hoop at Area 7? There's a nice court area and strong pole. But for several years, there is no backboard or hoop. What is the procedure to get one out up there? Our family would like to use that area.

**Kathy Cristino:** Wanted to know why there is no basketball hoop set up in area 7. Dan replied that there use to be 2 set up there and they both were destroyed. With cameras up a new aluminum backboard will be put up its more durable and hopefully won't get destroyed.

#### **NEW BUSINESS:**

\* Member/ Co Owners Clarification in Rules & Regulations: Regarding membership and purchase a yearly family pass, not including watercraft. The new wording has been clarified to read as follows - Co-owners will have privileges equal to any member in good standing with the yearly purchase of a family pass not including watercraft motorized and non-motorized registered in the state of Ohio. Providing the current member is in good standing.

Also, the third paragraph on page four but cannot be made into 6 lot parcels once separated has to do with the board in the 80's allowing 6 lot parcels to be grandfathered. Would like to entertain a motion to approve the rule change, also Al made mention of the changes that start on page 33 of the fee's being updated and Jeff helped with the wording on the fines.

Also changes pertaining to the dumpsters that they are to be used for normal household refuse generated and its not to be used for construction garages and other construction jobs such as that they are to pay for a dumpster to take their construction waste out of the lake appropriately. The trash removal is becoming very expensive.
